Note : ORIAS is the sole, official French register of insurance intermediaries and is updated annually. It was established in response to the requirements of European Union Law. Since 2007, it is a regulatory obligation for an intermediary in France to appear in the register in order to have the right to transact business. In particular, it testifies to the fact that the intermediary firm is professionally competent, is honorable and is covered by an adequate level of professional liability insurance. Furthermore, insurance intermediaries in France come under the supervision of the ACPR (Autorité de contrôle prudentiel et de résolution), a regulatory body attached to the Bank of France which is charged with preserving the stability of the financial system and protecting the customers, insurance policyholders, members and beneficiaries of the entities that it supervises.
